In case any violation is reported to the Council, appropriate penal action including withdrawal of approval shall be initiated against the Institution.
- (9) That the Institution shall not conduct any course(s) in the field of technical education in the san premisery compus and / or in the name of the Institution without prior permission/ approval of AICTE. Shall be initiated against the Institution.
- (h) The institution shall not conduct any non-technical course(s) in the same premises/ campus under a circumstances. In case any violation is reported to the Council, appropriate penal action include withdrawal of approval shall be initialest against the Institution.

3 That the institution shall execute only from the approved location, and that the institution shall not open any campus study centers! extension centers directly or in collaboration with any other institution university or approval from the AICTE.

  - (9) That the Institution shall not conduct any course(s) in the field of technical education in the same preference of the Institution without prior permission/ approval of AICTE. Case any Violation is reported to the Council, appropriate penal action including withdrawal of approval the instituted against the Institution.
  - (h) The institution shall not conduct any non-technical course(s) in the same premises/ campus under a circumstances. In case any violation is reported to the Council, appropriate penal action include withdrawal of approval shall be initiated against the Institution.

3 That the institution shall operate only from the approved location, and that the institution shall not open any campus study centers/ extension centers directly or in collaboration with any other institution/ university organization for the purpose of imparting technical education without obtaining prior approval from the AICTE.

- 4 That the tuition and other fees shall be charged as prescribed by the Competent Authority within the overall criteria prescribed by the Council from time to time. No capitation fee shall be charged from the students/ guardians of students in any form.
- 5 That the accounts of the Institution shall be audited annually by a certified Chartered Accountant and shall be open for inspection by the Council or any body or persons authorized by it.
- That the Director/ Principal and the teaching and other staff shall be selected according to procedures, qualifications and experience prescribed by the Council from time to time and pay scales are as per the norms prescribed by the Council from time to time.
- 7 (a) That the institution shall furnish requisite returns and reports as desired by AICTE in order to ensure proper maintenance of administrative and academic standards.
  - (b) That the technical institution shall publish an information booklet before commencement of the academic year giving details regarding the institution and courses/ programmes being conducted and details of infrastructural facilities including faculty etc. in the form of mandatory disclosure. The information booklet may be made available to the stakeholders of the technical education on cost basis. The mandatory disclosure information shall be put on the Institution Website. The information shall be revised every year with updated information about all aspects of the institution.
  - (c) That it shall be mandatory for the technical institution to maintain a Website providing the prescribe information. The Website information must be continuously updated as and when changes take place.
  - (d) That a compliance report in the prescribed format along with mandatory disclosures on fulfillment of th above conditions, shall be submitted each year by the Institution within the time limit prescribed by th Council from time to time i.e. 31\* August 2008 for the current year.
  - (e) That if Technical Institution fails to disclose the information or suppress and/ or misrepresent the information, appropriate action could be initiated including withdrawal of AICTE approval.
- 8 That all the laboratories, workshops etc. shall be equipped as per the syllabil of the concerned affiliated Universi and shall be in operational condition before making admissions.
- 9 That a library shall be established with adequate number of titles, books, journals (both Indian & Foreign) etc., per AICTE norms.
- 10 That a computer center with adequate number of terminals, Printers etc. shall be established as per AICTE norms
  - ACTE may carry out random inspections round the year for verifying the status of the Institutions to ensumeintenance of norms and standards.
  - 12 That the AICTE may also conduct inspections with or without notifying the dates to verify specific complaints mis-representation, violation of norms and standards, mal-practices etc.
  - 13 That the Institution by virtue of the approval given by Council shall not automatically become claimant to any grain and form the Central or State Government.
  - 14 That in the event of a student / candidate withdrawing before the starting of the course, the w listed candidates should be given admission against the vacant seat. The entire fee collected for the student, after a deduction of the processing fee of not more than Rs. 1000/- (Rupees C thousand only) shall be refunded and returned by the Institution / University to 1 student/candidate withdrawing from the programme. It would not be permissible for Institutional Universities to retain the School/Institution Leaving Certificates in original to force retention admitted students (See Public Notice AICTE/DPG/03(01)/2008).

- 15 "That the institution shall take appropriate measures for prevention of ragging in any form, in the light of directions of Supreme Court of India in Writ Petition No. (C) 656 / 1998.
